APPARATUS.

PROFESSORS EVE and LINDSLEY expect to spend the ensuing summer in Europe, where they will make extensive additions to the Anatomical and Pathological Museum and to the Chemical department. It is the intention of the Faculty to secure all the means of teaching each branch of Medicine as thoroughly as it can be taught anywhere.

CLINICAL INSTRUCTION.

Arrangements are being made for increased facilities for Clinical instruction, both Surgical and Medical. The members of the first class can attest the richness and variety of the Surgical Clinique during the past winter. Every opportunity will be embraced of presenting operations before the class, and all means used for illustrating the principles taught in the lectures.

OPENING OF THE COURSE.

The second course of Lectures will commence on the first Monday in November next. The Anatomical rooms will be opened for Students on the first Monday of October, under the supervision of the Professor of Anatomy.

PRELIMINARY LECTURES.

A preliminary course of Lectures will be given, commencing on the first Monday in October. All the Professors will take part in this course, and will lecture on topics which WILL NOT BE FULLY DISCUSSED in the regular Session. This is equivalent to a prolongation of the term, while at the same time it does not impair the unity of the course to those Students who do not come in till November. Three Lectures will be given daily throughout the month, and the following subjects will be presented to the class:

MINOR SURGERY, by Prof. Eve.

DISEASES OF FEMALES, by Prof. Watson.

SURGICAL PATHOLOGY, by Prof. Buchanan.

NOSOLOGY AND THE PRINCIPLES OF MEDICINE, by Prof. Bowling.

MEDICAL JURISPRUDENCE, by Prof. Winston.

GENERAL ANATOMY, by Prof. Porter.

PNEUMATICS, HEAT, ELECTRICITY, by Prof. Lindsley.

This arrangement is a virtual EXTENSION of the term to FIVE MONTHS.

PRACTICAL ANATOMY.

Such arrangements have been made as to secure an abundant supply of subjects for practical Anatomy. There is no law in our State against *importation*. Students need not fear the lack of material for dissection. [See resolutions on last page.]

REQUISITES FOR GRADUATION.

1. Three years regular study in the office of a regular physician.

2. Attendance upon two full courses of Lectures in a regular school of Medicine, the last of which must be in this Institution.

3. Four years reputable and regular practice will be accepted in lieu of one course of lectures, and such practitioner can become a candidate for graduation at the close of his first course.

4. The candidate for graduation must write a thesis on some medical topic and deposit it with the Dean by the first day of February.

5. The candidate must be twenty-one years of age, and of good moral character.

FEES.

The Fee for admission to each course of Lectures is fifteen dollars, payable in advance. The Matriculation fee is five dollars. The fee for the Diploma is twenty-five dollars.

Good board, including light and fuel, can be obtained in the city at from \$2 50 to \$3 00.

Summer Course of Medical Instruction.

At a called meeting of the Medical Class of the University of Nashville: On motion of R. P. Bateman, S. B. F. C. Barr was called to the Chair, and on motion of W. H. Pilcher, R. P. Bateman was appointed Secretary. The Chairman having stated the object of the meeting, as being to correct by preamble and resolutions the erroneous notion in relation to the scarcity of material for demonstrating Anatomy in the Medical Department of the University of Nashville. On motion, F. G. M'Gavock, T. B. Larue and J. B. M'Connell were appointed a committee to draft suitable resolutions. The committee after retiring a short time, returned with the following Preamble and Resolutions, which were unanimously adopted:

WHEREAS, It was frequently reported last summer much to the prejudice of this Institution, that there would not be a sufficiency of material for practical Anatomy. Therefore, be it unanimously

RESOLVED, by the Dissecting Class, That there was no foundation for the above report, but to the contrary, ample facilities have been afforded us for prosecuting this branch of Medical education,

RESOLVED, That the Dean of the Faculty be requested to place the above proceedings in the present announcement.
