How This Report Is Compiled

The Vanderbilt University *Annual Security Report* is published each year to provide you with information on security-related services offered by the university in compliance with the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act and the Tennessee College and University Security Information Act. This booklet was prepared with information provided to the Vanderbilt University Police Department by the Nashville Metropolitan Police Department, the Margaret Cuninggim Women's Center, the Department of Athletics, the Office of the Dean of Students, and the Office of Housing and Residential Education. It summarizes university programs, policies, and procedures designed to enhance your personal safety while you are here at Vanderbilt.



Vanderbilt University has a work force of nearly 25,000 and a student body population of nearly 13,000 including more than 5,400 living in student housing on campus. The Vanderbilt community also encompasses the Vanderbilt University Medical Center (VUMC), including two regional trauma centers. Vanderbilt's location, one and one-half miles from downtown and adjacent to Music Row, places it at the heart of Nashville's business and social scenes.

The commonly reported crimes, requests for services, and provisions for the safety of the Vanderbilt community on a 24-hour basis are similar to those of a city.

The nationally and internationally accredited Vanderbilt University Police Department comes under the charge of the Office of the Vice Chancellor for Administration. As one of Tennessee's larger law enforcement agencies, the Police Department provides comprehensive law enforcement and security services to all components of Vanderbilt University including the academic campus, Vanderbilt University Medical Center, and a variety of university-owned facilities throughout the Davidson County area. Commissioned and non-commissioned officers staff the department. Commissioned officers are empowered to enforce laws and make arrests through the authority of the Metropolitan Government of Nashville

and Davidson County. Vanderbilt commissioned officers have the same authority as Metropolitan Nashville police officers while on property owned by Vanderbilt, on adjacent public streets and sidewalks, and in nearby neighborhoods. When a Vanderbilt student is involved in an off-campus offense, police officers may assist with the investigation in cooperation with local, state, or federal law enforcement. Metro Nashville police routinely work and communicate with campus officers on any serious incidents that occur on campus. Vanderbilt University operates no off-campus housing or off-campus student organizations; however, many graduate students and some undergraduate students live in neighborhoods surrounding Vanderbilt. While Metro Nashville police have primary jurisdiction in all areas off campus, Vanderbilt officers can and do respond to incidents that occur in close proximity to campus. Vanderbilt officers have direct radio communications with the city police, fire department, and ambulance services to facilitate rapid response in any emergency situation.

All of Vanderbilt's commissioned officers have successfully completed law enforcement training at a state-certified police academy. In addition, all officers are required to attend annual in-service as well as on-the-job training.

We take campus security very seriously and are committed in our efforts to maintain a safe, secure environment for our students, faculty, staff, and visitors. Your personal safety is a priority at Vanderbilt. Maintaining a safe campus requires a dedicated partnership between the members of the Vanderbilt community and the Vanderbilt University Police Department.

Security is everyone's responsibility. We need your cooperation and assistance to keep Vanderbilt a safe place to live, work, and learn.

Emergency Response

ABOUT ALERTVU

AlertVU is Vanderbilt University's emergency notification system. In the event of an emergency, AlertVU serves as the primary initial emergency notification method for Vanderbilt University officials. It is designed to deliver a small amount of critical information in a very short time.

AlertVU rapidly sends messages to the delivery points a subscriber chooses. Users may enter as many devices as they wish and specify the device order in which they would like to be notified. AlertVU will be used only for emergencies posing an imminent threat or danger to the Vanderbilt community. Examples of such threats include a tornado headed directly towards Vanderbilt or One Hundred Oaks, or an active shooter on campus.

All students, faculty and staff at Vanderbilt are encouraged to sign up for the free service to assure notification in case of an emergency on campus. AlertVU is available to all Vanderbilt University students, faculty, and staff on a voluntary, opt-in basis. Students may also enter a contact number for a parent if they wish for a parent to be notified of emergencies at Vanderbilt. To sign up for Alert VU visit vanderbilt.edu/alertvu/.

ALERTVU POLICY

The Higher Education Opportunity Act (Public Law 110-315) was enacted on August 14, 2008, and reauthorizes the Higher Education Act of 1965 as amended under Title IV. The federal law requires all colleges and universities to have a notification and warning plan in place to alert the campus community of an emergency.

This policy establishes the emergency notification program at Vanderbilt University, commonly referred to as the AlertVU emergency notification system. The primary objective of the emergency notification system, AlertVU, is to provide a timely warning to students, faculty, and staff at Vanderbilt University during an emergency that poses an imminent threat or danger to the Vanderbilt community.

Vanderbilt University will, without delay, and taking into account the safety of the community, determine the content of the notification and initiate AlertVU, unless the notification will, in the professional judgment of responsible authorities, compromise efforts to assist victims or to contain, respond to, or otherwise mitigate the emergency.

EMERGENCY CONFIRMATION

The Vanderbilt University Police Department is designated as the first responder to all emergencies at Vanderbilt University. VUPD will respond to all emergencies and make a determination if an emergency poses an imminent threat or danger to the Vanderbilt community. This initial determination will be made by the highest-ranking on-scene officer.

This determination will proceed through a chain of command process and be ultimately confirmed by the Vanderbilt University Chief of Police or designee.

ALERTVU NOTIFICATION/ACTIVATION PROCEDURES

The AlertVU emergency notification system will be initiated once VUPD determines an emergency poses an imminent danger to the Vanderbilt community, and it is confirmed by the Vanderbilt University Chief of Police or designee. The Vanderbilt University Police Department will serve as the sole initiator for the AlertVU system.

The AlertVU system is a powerful communication tool designed to alert subscribed students, faculty, and staff. The system is designed to deliver a blanket message to every subscriber and every registered device via emails, phone calls, and SMS text messages. Activation procedures for the AlertVU emergency notification system are maintained in a separate and secure document. Given the sensitive nature of the contents of the Activation Procedures document, it is considered CONFIDENTIAL and FOR OFFICIAL USE ONLY.

ALERTVU MESSAGE CONTENT

VUPD will determine the content of all AlertVU messages based on the nature, severity, and duration of each emergency. The AlertVU system contains pre-approved messages by university officials which are eligible for immediate activation. The titles of pre-approved messages are listed below:

- VU Tornado Warning
- VU Main Campus Shooting
- VUMC Shooting
- VU Commons Shooting
- Near Campus Shooting
- VU Building Shooting
- VU Emergency Situation
- 100 Oaks Shooting
- Tornado Warning Cancellation
- Bomb Threat

ALERTVU TESTING PROCEDURES

The AlertVU emergency notification system at Vanderbilt University is tested annually. The test is conducted collaboratively by VUPD and the Vanderbilt University Environmental Health and Safety Department.

The annual test message is sent to every subscriber and every registered device. The message is initiated using the AlertVU activation procedures. The annual test results are documented and available for review.

The most recent full-scale test of the AlertVU emergency notification system was on February 22, 2012, and it was an announced test. AlertVU was activated by VUPD on March 2, 2012, when a severe storm and possible tornado were heading directly toward the Vanderbilt main campus.

CRISIS COMMUNICATION TO THE VANDERBILT COMMUNITY

In addition to Alert VU, Vanderbilt University has worked very hard to identify additional communication tools to deliver larger and more complex emergency messages to the Vanderbilt community. Vanderbilt University News and Communications will serve as the primary news source during all emergencies at Vanderbilt. News and Communications has several communication tools ready and available to deliver detailed and complex emergency information. Some of those communication tools are:

Campus and Medical Center Physical Security

ADMINISTRATIVE AND CLASSROOM FACILITIES

The administrator of each department is responsible for physical security and determining access rights and hours. In general, classroom buildings are locked after the last class in the building ends, and administrative buildings are locked after normal business hours.

MEDICAL CENTER FACILITIES

After hours entrance to Medical Center buildings is restricted to designated points.

RESIDENCE HALLS

The Office of Housing and Residential Education works closely with the Vanderbilt University Police Department, Plant Operations, Buildings and Grounds, Campus Planning, and other departments to maintain and enhance the physical security of the residence halls. Throughout the academic year, the office sponsors educational programming for residents about residence hall security and safety. Student housing for undergraduates consists of single, double, and triple rooms, apartments, suites, and lodges.



First-year students are housed at The Ingram Commons, separate from other students.

The residence hall system is divided into seven administrative areas. Each area consists of a cluster of residence halls and has a central information desk staffed 24 hours a day, seven days a week. Information desk attendants respond to a variety of situations and have been trained in university resources, customer service skills, and the operation of door and fire alarm panels. Each residential area has a minimum of one live-in professional staff member on call 24/7 and a large, live-in, paraprofessional staff. All residence halls are equipped with smoke detectors and sprinkler systems. All residence halls are accessed via electronic key card. Electronic access is restricted to residents or authorized users of a residential area or building at all times. In some buildings, combination locks or electronic access devices further restrict access to corridors. Desk attendants may require residents to show their university identification cards to access residence halls. Residents are expected to escort their guests, especially non-student guests. Solicitation in halls is prohibited without authorization. Generally, persons who are not guests of residents are not permitted in residence halls.

Cameras have been installed at all entry/exit points and in common areas. Most residence hall exit doors will trigger an audible alarm if they are opened during darkness. Keys to individual student rooms are unmarked to prevent unauthorized use in case they are lost. All operable windows have securing mechanisms.

Broken windows or locks should be reported immediately to the Resident Adviser, to the Area Maintenance Supervisor, or online at <https://apphost2.its.vanderbilt.edu/housing/Facilities/Main/Request.cfm>.

Exterior doors that have been propped open should be closed and reported immediately to the Resident Adviser or during normal business hours to the Area Maintenance Supervisor.

Tampering with or disabling security devices and smoke detectors may lead to disciplinary action.

Residence halls are closed during breaks. Students who need housing over breaks may register for housing and be permitted to remain in their halls.

Residence hall fires are tracked by Vanderbilt University Environmental Health and Safety (VEHS). VEHS maintains the Fire Safety Log and publishes the *Annual Fire Safety Report* in compliance with the Higher Education Opportunity Act (HEOA), which became public law 110-315 in August 2008 and requires all institutions of higher education with student residential housing facilities to publish an annual fire safety report. Per HEOA requirements, this report details elements of the Vanderbilt University Campus Fire Safety Program and includes information on fire prevention policies and practices, fire safety educational and training initiatives, an overview of fire protection equipment in the residence halls, emergency evacuation procedures, fire safety statistics, and proposed plans for future improvements to the student residence fire safety program.

These reports remain available for three years.

MAINTENANCE OF CAMPUS FACILITIES

Facilities and landscaping are maintained in a manner that minimizes unsafe conditions. VUPD regularly patrols the campus and reports malfunctioning lights and other unsafe physical conditions to the appropriate department for correction. VUPD conducts a semi-annual Campus Lighting Assessment Tour. Students, staff, and members of Student Housing, Campus Planning, and Plant Operations are invited to participate. These tours assess popular pedestrian travel routes on campus and identify areas where additional lighting or physical improvements may enhance the overall safety and security of the area.

Members of the Vanderbilt community are encouraged to report potentially unsafe or hazardous conditions to VUPD, Campus Plant Operations, or VUMC Plant Services at any time throughout the year:

IDENTIFICATION CARDS

All students, faculty, and staff members at Vanderbilt University are issued Commodore Cards. All faculty and staff must be active in Human Resources before receiving a card. A valid photo ID (e.g., a driver's license) is also required. VUMC employees and temporary staff receive cards in the round wing of Medical Center North, room S-2311. University Central employees receive cards in room 184 of Sarratt Student Center. Cards may be used to gain access to certain locations and may be used to make purchases from university facilities.

Lost or stolen Commodore Cards should be reported immediately to the Commodore Card Office by telephone at (615) 322-2273 during regular business hours. Students may also report lost or found cards online at studentorgs.vanderbilt.edu/vsg/services/temporary-access-cards/. If a student loses his or her card when the Commodore Card Office is closed, the student may get a temporary access card valid for his or her campus residence at the Branscomb Reeves Desk. Lost or stolen VUMC ID cards should be reported to the VUMC Card Office at (615) 936-3350 during regular business hours. Any stolen card should also be reported immediately to the Vanderbilt University Police Department.

OTHER PHYSICAL SECURITY MEASURES

Closed circuit television (CCTV) cameras are in place at various locations around the Vanderbilt campus. University administrators for each building or area are responsible for determining the need, the location, the installation, and the maintenance of CCTV systems. VUPD will assist building or area administrators with camera systems upon request. Recorded images may be used as evidence in criminal and/or university investigations.

Emergency Phones

Emergency telephones are located throughout the university and Medical Center. Each phone has an emergency button that, when pressed, automatically dials the VUPD Communications Center. An open line on any emergency phone will activate a priority response from VUPD. An officer will be sent to check on the user of the phone even if nothing is communicated to the communication officer. Cooperation is essential to help maintain the integrity of the emergency phone system, which should be used only for actual or perceived emergency situations.

Emergency response from the Vanderbilt University Police Department may also be obtained by calling 911 from a campus phone or (615) 421-1911 from a cell phone. For off-campus emergencies, callers should dial 911. In every case, callers should be prepared to state their locations.

After-Hours Transportation and Walking Escorts

VUMC SHUTTLE SERVICE

The VUMC shuttle service operates to and from the Medical Center, designated Medical Center parking areas, and 100 Oaks clinics on business days. The VUMC shuttle service is not available on weekends. For VUMC shuttle information, call (615) 936-1215.

Please be patient on ballgame nights and at other times when traffic is congested. Your shuttle's arrival may be delayed at those times. When leaving a shuttle bus, try to walk in groups. If you are alone, and your destination is only a few feet away, ask the driver to

pause and watch you walk to your vehicle. Should you have a problem, inform the appropriate shuttle supervisor in a timely fashion, so that future difficulties may be avoided.

VANDY VANS

The Vandy Vans shuttle bus system, administered by VUPD, provides pick-up and drop-off service to designated points on campus. The service operates from 5:00 p.m. to 5:00 a.m. during the fall and spring semesters. VandyVans also operates Beyond the Bubble Service, Thursday through Saturday, from 6:00 p.m. to 11:00 p.m. This service is provided to select off-campus locations. Stops for Vandy Vans services are chosen based on the accessibility of a waiting area and student recommendations. Mounted or freestanding signs identify each stop. Riders can request a walking escort to walk them from the van stop to their final destinations. Students can check the location and seating availability of Vandy

Vans using their computers or cell phones, and they can even set up text message alerts to let them know when the vans are arriving at their stops. Additional information about Vandy Vans and routes is available online at police.vanderbilt.edu/services/vandy-vans/ or vandyvans.com/.

WALKING ESCORT SERVICE

As a supplement to the Medical Center Shuttle Service and Vandy Vans, VUPD provides walking escorts for students, faculty, and staff on campus during hours of darkness. A walking escort may be requested by dialing (615) 421-8888.

COMMODORE CAB

Taxi USA has outfitted 200 vehicles from local cab companies (Diamond, Allied, and Nashville) with card readers that allow students to swipe their Commodore Cards in lieu of paying cash for cab rides. This system also allows students to split the fare with up to three people. Vehicles participating in the program are marked with a "Commodore Cab" decal.

Funds can be added to a student's Commodore Card by billing his or her student account or by adding cash in the Commodore Card Office. This is the same account used for laundry, bookstore purchases, etc.

Crime Prevention and Safety Awareness Education

Crime prevention and personal safety awareness programs are available from several resources at Vanderbilt. The following departments and organizations sponsor prevention services/programs and provide advice and educational programs:

Student organizations and associations routinely sponsor programs and speakers on personal safety and awareness.

All freshman students may complete two online safety training modules as part of their new-student orientation. The modules instruct students about fire safety and safety and security on campus.

RISK REDUCTION TIPS

Personal Safety

- Walk or jog in groups of three or more.
- Be aware of your surroundings.
- Be aware of crimes on and around campus.
- Avoid isolated or dark areas.
- Travel with confidence and purpose.
- Do not wear earphones while walking or jogging.
- If you can't find traveling companions, use the escort service on campus, no matter how short the distance.
- Before exiting a building or car, look around the area for anything suspicious.
- If confronted by a situation, try to remain calm.
- If it is safe to do so, try to get a detailed description of suspects or suspicious persons and/or their vehicle(s).
- Call VUPD at (615) 322-2745 to request an officer to meet you and walk you to or from your vehicle or next campus destination.
- Know the locations of emergency telephones.
- Do not use ATMs (automated bank teller machines) alone, at night, or when someone suspicious is nearby.
- Avoid strangers. You do not have to stop and talk to them.
- If you are being followed, go to the nearest area of safety.
- Stay alert, and plan ahead for "What if...?"

Residential/Workplace Safety

- Know your neighbors or co-workers. You are the best one to determine who does not belong.

- Do not prop open exterior doors.
- When entering a building with access control in place, do not allow strangers to enter behind you.
- Always lock your door when you leave, sleep, or work late.
- If you see someone you consider suspicious or out of place, **call Vanderbilt University Police immediately.**

Protecting Your Property

- Register your bicycle, laptop, iPad, and tablet with the Vanderbilt University Police Department.
- Record the serial numbers of your belongings. Engrave or permanently mark items with a unique identifying number.
- Keep your car locked.
- Store items out of sight or in your room/office.
- Coats, backpacks, and purses should remain with you or be locked up.

Reporting Crimes and Other Emergencies

All victims are encouraged to report crimes and emergencies to VUPD. Vanderbilt officers are primary responders to any emergency or criminal situation on campus. Direct radio and phone communications with local police, fire, and emergency medical services ensures that officers can initiate and direct necessary emergency responders to the area. In an emergency situation, dialing 911 from any Vanderbilt telephone will contact the Vanderbilt University Police Department communications center. A trained communication officer will then direct the appropriate response to your emergency. For non-emergency calls to the Police Department, call (615) 322-2745.

Because police reports are public records under state law, the Vanderbilt University Police Department cannot hold reports of crime in confidence. Victims of crime on campus are strongly encouraged to report all crimes directly to VUPD to ensure inclusion in the Daily Crime Log and Annual Crime Statistics. This also ensures that timely warning notices to the community are distributed when appropriate. For example, a crime that is reported only to Project Safe counselors or only to pastoral staff on campus may not be included in the annual Vanderbilt crime statistics and may not trigger a Security Notice to our community. Support for Victims of Crime

Victims of crime at Vanderbilt can expect to receive compassion and support from a variety of resources on campus

VUPD Office of Crime Prevention

Provides advocacy, referrals, and support for students, staff, and visitors who are victims of crime at Vanderbilt. May accompany a victim to the hospital or to court, assist in obtaining protective orders or warrants, coordinate with the District Attorney's Office, and guide the victim through the Criminal Justice system. Project Safe

Offers resources and referrals for all Vanderbilt community members affected by power-based personal violence, including stalking, sexual violence, intimate partner violence, and bullying. Project Safe is housed in the Margaret Cuninggim Women's Center, in the Office of the Dean of Students. Psychological and Counseling Center (PCC)

Zerfoss Student Health Center

Provides medical assistance to survivors of power-based personal violence, including emergency contraception and sexually transmitted infection testing, and covers the medical fees associated with the medical-legal exam, or rape kit, when administered at the Vanderbilt University Emergency Room. Office of Student Conduct and Academic Integrity

Works with students to uphold the Sexual Misconduct Policy and give students the opportunity to pursue disciplinary proceedings against a student offender. The office will also issue an order to the offending student to desist from the conduct in question when necessary. Green Dots

The Green Dots campaign is a coordinated campus effort to reduce and prevent power-based personal violence, including stalking, sexual violence, intimate partner violence, and bullying. Crime Response

Vanderbilt University Police Department procedures require that calls involving crimes against persons and life/safety issues, such as fire or injury, receive priority response from the department. Property crimes in progress and other criminal acts with a high potential for violence also necessitate a rapid response. Requests for officers to file reports on criminal acts not actually in progress or general assistance requests are taken in the order received.

VUPD responds to crime at Vanderbilt in much the same way as any other urban law enforcement agency would respond. An incident is documented with a report, which is then filed with the Metropolitan Nashville Police Department. Vanderbilt University Police Department officers preserve and collect evidence from criminal incidents occurring at the university. Crimes against persons, including sexual assaults, may be jointly investigated and reviewed by VUPD and MNPD. *Tennessee Code Annotated 49-7-129* and a Memorandum of Understanding between the two agencies determines primary jurisdiction.

Members of the community can stay informed about criminal incidents at Vanderbilt University by reading the Daily Crime Log or Security Notices distributed to members of the Vanderbilt community as part of an ongoing effort to keep the community informed and to raise awareness of significant unsolved crimes that occur at or near the university.

Security Notices are issued in compliance with the Higher Education Act (20 U.S.C. 1092(f)). This act requires that a timely warning be issued when one of the below incidents occurs on or near Vanderbilt facilities or property, and there is reason to believe that there is a continued threat to students and/or employees:

- (A) Murder;
- (B) Sex offense, forcible or non-forcible;
- (C) Robbery;
- (D) Aggravated assault;
- (E) Burglary;

- (F) Motor vehicle theft;
- (G) Manslaughter;
- (H) Arson; or
- (I) When repeated offenses warrant public notice, such as multiple unsolved thefts with the same possible suspect(s) or established pattern(s).

The department may also issue a Security Notice for any crime when there is a compelling need to get information to the Vanderbilt Community.

A Security Notice will contain as much of the following information as possible:

- Vanderbilt University Police Department incident number and Metropolitan Nashville Police Department incident number
- Date, time, location (general or specific), and summarized event description
- Suspect description and/or vehicle description
- Any special instructions that may be needed

A Security Notice will be issued as soon as possible after the specific event. If the incident is a delayed report (more than 24 hours) by the victim, then the time and date the victim reported the incident will also be included in the notice. The Security Notice will not contain information that may hinder an ongoing police investigation and will not identify the victim by name or address. A general location, such as dormitory or fraternity, may be given instead of a specific location to ensure the privacy of the victim.

Security Notices are distributed through a listserv to all active Vanderbilt students, faculty, and staff and through the VUPD website at police.vanderbilt.edu.

The Vanderbilt University Police Department also maintains a Daily Crime Log in compliance with the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act and the Tennessee College and University Security Information Act. Persons may view the log at the VUPD office located at 111 28th Avenue South, during normal business hours, or online at police.vanderbilt.edu/crime-info/daily-crime-log/.

Weapons

Tennessee law and university policy prohibit anyone other than on-duty commissioned police officers from carrying weapons on campus. Students who plan to use weapons in legal recreational activities may store them for safekeeping at the Vanderbilt University Police Department located at 111 28th Avenue South. For complete information including the required forms, visit police.vanderbilt.edu.

Criminal Convictions

Being convicted of a crime outside the workplace may render a staff member unsuitable for continued employment at the university. Vanderbilt reserves the right to terminate

employment if an individual is convicted of a crime, even if the crime did not occur on Vanderbilt time or premises. If an employee is convicted of a crime, the employee is required to notify his or her immediate supervisor within five (5) days of the conviction. Failure to report a conviction, or being convicted of a crime that makes a person unsuitable for continued employment, may be grounds for termination of employment. Criminal convictions prior to employment at Vanderbilt will not necessarily bar employment. Falsification of application materials, however, including failure to disclose convictions or guilty pleas for any violation of the law, whether or not the employee served time, is grounds for termination of employment at any time after the falsification is discovered.

Sexual Offender Registration

The Tennessee Bureau of Investigation (TBI) maintains the TBI Sexual Offender Registry, a central information and registration system of sexual offenders located in Tennessee. Information concerning registered sexual offenders can be obtained from the TBI Sexual Offender Registry by calling (1-888) 837-4170 between 8:30 a.m. and 4:30 p.m., CST, Monday through Friday (excluding holidays) or by visiting the TBI website at tbi.tn.gov/sex_offender_reg/sex_offender_reg.shtml.

Sexual Assault Prevention and Response

Vanderbilt University educates the student community about sexual assault during mandatory freshman orientations each fall. The Vanderbilt University Police Department also offers sexual assault education and information programs to university students and employees upon request.

If you are a victim of a sexual assault at Vanderbilt, your first priority should be to get to a place of safety. You should then obtain necessary medical treatment. The Vanderbilt University Police Department strongly advocates that a victim of sexual assault report the incident in a timely manner to the Police Department by calling 911 or (615) 322-2745. Time is a critical factor for evidence collection and preservation. Filing a police report with a Vanderbilt officer will not obligate the victim to prosecute, nor will it subject the victim to scrutiny or judgmental opinions from officers. Filing a police report will:

- Ensure that a victim of sexual assault receives the necessary medical treatment and tests, at no expense to the victim
- Provide the opportunity for collection of evidence helpful in prosecution, which can not be obtained later (Ideally, a victim of sexual assault should not wash, douche, use the toilet, or change clothing prior to a medical/legal exam.)
- Assure the victim has access to free confidential counseling from counselors specifically trained in the area of sexual assault crisis intervention.

The University will make interim accommodations (academic, residential, or otherwise) for a student who has filed a complaint alleging a violation of the sexual misconduct policy and will take any other interim actions that are appropriate to ensure the safety and security of the campus community, as necessary.

When a sexual assault victim contacts VUPD, the Metro Nashville Police Sex Crimes Unit will be notified as well. Sex offenses are investigated by VUPD or MNPD in accordance with the MOU. A representative from the Office of Housing and Residential Education may also be notified, if the victim is a student. The student victim of a sexual assault may choose for the investigation to be pursued through the criminal justice system, the University Conduct Council, or both.

A representative from the Vanderbilt University Police Department or the Office of Housing and Residential Education will guide the victim through the available options and support the victim in his or her decisions. Various counseling options are available from the university through the Zerfoss Student Health Center, the Margaret Cuninggim Women's Center, the Office of Religious Life and Affiliated Ministries, Work/Life Connections—EAP, and the Psychological and Counseling Center. Counseling and support services outside the Vanderbilt system can be obtained through a 24-hour crisis and support line offered by the Sexual Assault Center in Nashville at (800) 879-1999. The Victim Intervention Program of the Metropolitan Nashville Police Department also operates a 24-hour on-call service to victims and citizens involved in crimes reported to the police.

University disciplinary proceedings, as well as separate and distinct policies and procedures governing cases involving sexual misconduct, are detailed in the *Student Handbook*

at vanderbilt.edu/student_handbook/. The *Student Handbook* provides, in part, that both the complainant and the respondent in a sexual misconduct case will be informed in writing of the outcome of the investigation and that both parties have the ability to appeal the determination. A detailed description of the grievance procedures is also provided. A student found responsible for violating the university's sexual misconduct policy may be suspended or expelled from the university for the first offense.

Alcohol and Illegal Drug Use on Campus

Vanderbilt University is concerned about the health and safety of our students and the unlawful and irresponsible use of alcohol and other drugs. To address this issue, the Office of Student Wellness Programs and Alcohol Education serves the university community by providing program presentations, resources, and activities for students. This office is responsible for educational programs, awareness campaigns, advising student organizations on alcohol and other drug issues, data collection, and environmental approaches to prevention. For students in recovery, this office provides information about Vanderbilt Recovery Support and its programs. Contact the office at alcohol@vanderbilt.edu or (615) 343-4740.

The *Student Handbook* states the university's position on alcohol and illegal drug use, in part, as follows:

The university prohibits the unlawful possession, use, or distribution of alcohol and controlled substances by students, faculty, and staff on its property or as part of any university sponsored activity. The prohibition extends to off-campus activities that are officially sponsored by Vanderbilt, its schools, departments, or organizations. In addition, the prohibition extends to off-campus professional or organizational activities, including attendance at conferences, when participation is sponsored by the university, or when the participating student, faculty member, or staff member is representing the university. Finally, the prohibition extends to "private" events off campus where the university may have an interest (e.g., if a student were to provide alcohol to underage students at an off-campus location). To underscore the seriousness with which it takes the issue of health and welfare of its constituent populations, the university will impose disciplinary sanctions on students, faculty, and staff—up to and including expulsion or termination of employment, and possible referral for prosecution—for violation of the alcohol and controlled substances policy. Conditions of continued employment or enrollment may include the completion of an appropriate rehabilitation program.

Additional standards of conduct, disciplinary standards, and procedures may be found in the *Student Handbook*, the *Faculty Manual*, applicable union contracts, and in the following Vanderbilt and VUMC policies: HR Substance Abuse Policy, HR policy Drugs and Alcohol, VUMC Alcohol and Drug Use Policy (OP 30-10.4), HR Anti-Harassment Policy, HR Performance Management Process, HR Workplace Violence Policy, VUMC Professional Conduct Policy (OP 30-10.13), and VUMC Management of Disruptive and



Aggressive Behavior Policy (zero tolerance) (SA 10-10.06). Tennessee’s legal drinking age is twenty-one (21). University policy states that alcoholic beverages may not be served, furnished, or distributed to persons younger than twenty-one years of age. The *Student Handbook* details the following penalties:

The minimum sanction for simple purchase, possession, or consumption of alcohol in violation of university policy is a reprimand for the first offense. The completion of an appropriate assessment will also be required. The presumptive sanction for first-offense intoxication is disciplinary probation. Standard indicators of drinking to the level of intoxication may include lack of balance, loss of coordination, confusion, slurred speech, bloodshot eyes, odor of intoxicant, etc.

The minimum penalty for driving under the influence of alcohol or other drugs is disciplinary probation and loss of campus driving and parking privileges. Unlawful provision, distribution, or sale of alcohol or other drugs by a student in violation of university policy will result in serious disciplinary action, which may include suspension or expulsion for the first offense, and may also result in criminal prosecution. The presumptive sanction for a student who illegally distributes alcohol to an underage student is disciplinary probation for the first offense. Persons who unlawfully furnish alcoholic beverages to students who are not of legal drinking age may also be held responsible for personal injuries or property damages resulting from misconduct committed by underage, intoxicated students. The presumptive sanction for a third violation of alcohol or controlled substances policies is suspension. Violations involving behavior that injures persons, that damages property, or that injures or damages the community at-large, will increase the presumptive strength of the sanction given. In addition, disciplinary sanctions will be imposed for misconduct that results from the use of alcoholic beverages or other drugs. Students will also be held responsible for any damages that result from their misconduct. These sanctions will be imposed consistent with disciplinary standards and procedures found in Chapter 3, “Student Conduct.”

Tennessee alcohol and controlled substance laws and penalties, university resources, and the health risks associated with the use of alcohol and controlled substances are also detailed in the *Student Handbook*. An additional resource for students, faculty, and staff can be found at vanderbilt.edu/alcohol/. This website has links to Tennessee laws and penalties, and local and national resources. For university staff, the Work/Life Connections—Employee Assistance Program website is healthandwellness.vanderbilt.edu/work-life/

Missing Student Notification Policy

In compliance with the Higher Education Opportunity Act of 2008, Vanderbilt University provides each student residing on campus the opportunity to designate a confidential contact to be notified by the university in the event that the university, through

its established procedures, determines that a student is missing. Although not required, Vanderbilt makes the missing student notification procedure available to all students.

This confidential contact is in addition to any other emergency contact that the student may identify, although both the confidential contact and the emergency contact(s) may be the same person or persons. In the case of non-emancipated students under the age of eighteen, the HEOA requires that a custodial parent or guardian be notified; however, an additional confidential contact may also be specified. Students may designate both emergency contacts and confidential contacts by logging into YES (Your Enrollment Services) at yes.vanderbilt.edu and selecting the appropriate process.

During the first 24 hours after the Vanderbilt University Police Department has determined that a student is missing, the Dean of Students or one of the dean’s designees will notify the student’s confidential contact. Vanderbilt University Police Department will also notify appropriate external law enforcement agencies and others at the university about the missing student.

One Hundred Oaks is located at 719 Thompson Lane in Nashville, several miles from campus. In 2009, the data for both locations was combined. Crime Statistics by Year Reported and Location

The information below provides context for the crime statistics reported as part of compliance with the Clery Act.

(In compliance with the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act)

The procedures for preparing the annual disclosure of crime statistics include reporting statistics to the University community obtained from campus officials with significant responsibility for student and campus activities and security. The following sources provided data for this report: Vanderbilt University Police Department, the Metropolitan Nashville Police Department, the Associate Provost and Dean of Students, and the Assistant Vice Chancellor for Student Athletics, Recreation, and Wellness.

Crime statistics are reported annually to the Vanderbilt community via the "Annual Security Report," published by VUPD. Vanderbilt University then submits the annual crime statistics published in this booklet to the Department of Education (DOE). The statistical information received by DOE is available to the public through their website at ope.ed.gov/security/.

Current students and employees are provided notice on an annual basis of the availability of this report on the Vanderbilt University website, and in booklet format. The notice states:

In compliance with the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act and the Tennessee College and University Security Information Act, Vanderbilt University publishes an annual report to provide information on security-related services offered by the university. The Annual Security Report contains information related to university-wide security and safety, including related policies, procedures, and criminal statistics. The Annual Security Report can be found at the Vanderbilt University Police Department website at police.vanderbilt.edu/annual-security-report/, or a copy may be obtained from the Vanderbilt University Police Department at 111 28th Avenue South, Nashville, Tennessee 37212. The report will be available after September 30, 2012.

Specific Information about Classifying Crime Statistics

The statistics in this brochure are published in accordance with the standards and guidelines used by the FBI *Uniform Crime Reporting (UCR) Handbook* and relevant federal law (the Clery Act). The number of victims involved in a particular incident is indicated in the statistics column for the following crime classifications: murder/non-negligent manslaughter, negligent manslaughter, forcible and non-forcible sex offenses, and aggravated assault. For example, if an aggravated assault occurs, and there are three victims, this would be counted as three aggravated assaults in the crime statistics chart. The number reflected in the statistics for the following crime categories includes one offense per distinct operation:

robbery, burglary, larceny, vandalism, and arson. For example, if five students are walking across campus together, and they are robbed, this would count as one instance of robbery in the crime statistics chart. In cases of motor vehicle theft, each vehicle stolen is counted as a statistic.

Hate Crimes

Vanderbilt Programs Outside Nashville

Vanderbilt conducts programs during the summer in Washington, D.C., and locations outside of the United States. In some instances, Vanderbilt may lease classroom and living space for the students participating in these programs, and security is provided by the leasing entity and local police authorities. Specific questions about security at program facilities and housing should be raised with the sponsoring department and the faculty member or administrator in charge of the program. All victims are encouraged to report crimes to local police, the department or school sponsoring the program, and the Vanderbilt faculty or administrator in charge of the program. Vanderbilt has received no reports of crime occurring at property leased in connection with its summer programs in Washington or abroad in 2009, 2010, or 2011.

OFFENSE DEFINITIONS

The Clery Act requires that statistics be reported for seven (7) crimes, and liquor law violations, drug law violations, and illegal weapons violations. The offenses are defined according to the FBI Uniform Crime Reporting/National Incident-Based Reporting System as follows:

Arson

To unlawfully and intentionally damage, or attempt to damage, any real or personal property by fire or incendiary device.

Aggravated Assault

An unlawful attack by one person upon another wherein the offender uses a weapon or displays it in a threatening manner, or the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness.

Burglary

The unlawful entry into a building or other structure with the intent to commit a felony or a theft.

Criminal Homicide

Murder and Non-Negligent Manslaughter

The willful killing of one human being by another.

Negligent Manslaughter

The killing of another person through gross negligence.

Drug/Narcotic

The violation of laws prohibiting the production, distribution, and/or use of certain controlled substances and the equipment or devices utilized in their preparation and/or use.

Liquor Law

The violation of laws or ordinances prohibiting the manufacture, sale, purchase, transportation, possession, or use of alcoholic beverages. Drunkenness and driving under the influence are not included.

Motor Vehicle Theft

The theft of a motor vehicle.

Robbery

The taking, or attempting to take, anything of value under confrontational circumstances from the care, custody, or control of a person by force or threat of force or violence and/or by putting the victim in fear of immediate harm.

Sex Offenses

Forcible

Any sexual act directed against another person, forcibly and/or against that person's will; or not forcibly or against the person's will where the victim is incapable of giving consent. The category includes forcible rape, forcible sodomy, sexual assault with an object, and forcible fondling.

Non-forcible

Unlawful, consensual sexual intercourse. There are two types of non-forcible sexual offenses: incest and statutory rape.

Weapons Law

The violation of laws or ordinances prohibiting the manufacture, sale, purchase, transportation, possession, concealment, or use of firearms, cutting instruments, explosives, incendiary devices, or other deadly weapons. Includes violations such as the manufacture, sale, or possession of deadly weapons; carrying deadly weapons, concealed or openly; using, manufacturing, etc., silencers; and furnishing deadly weapons to a minor.
